- a) Prices;
- b) Methods, factors or formulas to calculate prices;
- c) The intention or decision to submit or not to submit, a bid; or
- d) Any other indication of collusion regarding bid process.

The County may, in its discretion, take any action it considers appropriate including rejecting any bid or disqualifying any bidder from bidding on this tender or another tender.

All bids are irrevocable for a period of fourteen (14) days from tender closing date. All tenders become the property of Red Deer County until such time as a tender is awarded or rejected. No multiple bids for the same vehicle will be accepted.

TENDER SCORING

Tenders will be evaluated based on the following scoring criteria: Tender amount shall be worth 90% of the total score, while the type of agency / individual submitting the tender shall be worth 10%. Public sector emergency response agencies shall receive a full score of 10% in this category.

Red Deer County reserves the right to accept or reject the highest and/or any of the tenders. Red Deer County has the right not to accept any and all tenders.
